

SAFE Framework of Standards



Principles & Objectives

- Establish security and facilitation standards at a global level.
- Enable integrated supply chain management for all modes.
- Enhance Customs capabilities for the 21st century.
- Strengthen cooperation between Customs administrations via MRA and AEO networks.
- Promote seamless movement of goods through secure supply chains.
- Strengthen cooperation between Customs and:
 - other Customs administrations
 - Businesses, via MRA and AEO
 - Other Government Agencies



5 Core Elements

- 1. Harmonize advance cargo information.
- 2. Employ consistent risk management.
- 3. Outbound inspections of high-risk cargo.
- 4. Customs-driven benefits to member businesses.
- 5. Promote cooperation with federal agencies across regulatory areas.

Evolution of the Importer Self Assessment (ISA) Program









ISA Program

2002

Importers assess their own compliance with CBP laws and regulations.

Trusted Trader Pilot

2016

Pilot program to integrate ISA alongside CTPAT Security to achieve a full-fledged AEO status.

2022

Initial launch in 2020 and ending the TT Pilot in 2022, CTPAT now includes Security and Trade Compliance as a full AEO program.

CTPAT Trade Compliance

CTPAT Trade Compliance

- Importers & CA NRIs only
- Comprehensive Internal Controls & Audit Trail
- Compliance, not Security

Benefits include:

- CBP National Account Manager
- Disclosure's Benefit
- Expedited Customs Rulings
- Removal from Focused Assessment pool
- New Forced Labor considerations

CTPAT Security

- Open to Importers, Exporters, Foreign Manufacturers, Transportation, and Service companies
- Minimum Security Criteria (MSC)
- Security & Risk, not compliance

Benefits include:

- Assigned CTPAT Supply Chain Security
 Specialist
- Reduced number of border examinations, shorter border wait times, and FAST Lane
- Pre-requisite for other US Gov't pilot programs, incl. ISA / now CTPAT Trade Compliance
- Priority consideration following disruptive event



2. Solving Trade Compliance Internally









Awareness

Comprehensive understanding of all ongoing import activity, related regulatory controls and programs, and strategy in place for navigating the macro and micro aspects of import transactions.

Execution

Strategy and program fully implemented, includes active monitoring of all import activities, evaluation of risk environment, and systemic control of import practices.

Controls

Program in place for periodic testing, correction, and improvement of import practices, including Disclosures.

Must be able to demonstrate controls, corrective actions and results.

- Classification
- Country of Origin
- Free Trade Agreements
- Record Keeping
- Duty Payment
- AD/CVD
- Forced Labor
- Drawback

Application Requirements

- Be a Tier 2 or Tier 3 CTPAT Security Importer in good standing
- Be current on all payments to CBP
- Complete the Eligibility Questions in the affirmative (Appendix A)
- Complete the Application Questionnaire (Appendix B)
- Complete the Memorandum of Understanding (Appendix C)
- Submit application via the CTPAT Web Portal

Eligibility Questions

Authority to do business without approval of another person outside the U.S. or Canada?

🐙 Star USA

- Active Importer
- Separate financial records from any other company, direct payment of duties & fees
- Continuous Import Bond
- Internal Control System is already in place
- Perform annual risk assessments and appropriate adjustments
- Audit trail of financial records for imports
- Appropriate history of prior disclosure, reconciliation, PSC, and other CBP interaction
- Agreement to notify CBP of all organizational changes

4. Customs Review & Acceptance





Trust, but Verify

Following your application submission, CTPAT teams will review and schedule an Application Review Meeting (ARM) where they will verify the information you provided in the application.

Once approved, CTPAT will establish partnership by counter-signing the Memorandum of Understanding (MOU).

After you have been approved, you will start receiving the benefits of CTPAT Trade Compliance.
